Currently, he is teaching at Politecnico of Milan in social innovation and social entrepreneurship, and he is an associate of TIREZIA, the International Research Center on Social Innovation Ecosystem, promoted by Politecnico of Milan School of Management. He regularly cooperates with training institutions and participates as speaker at events and congresses regarding impact investing, social innovation, and social entrepreneurship. In addition, he is the author of many publications, particularly regarding nonprofit organizations, social entrepreneurship, and impact investing. Randazzo was a member of the commission for the reform of Book 1 of the Italian Civil Code (2005) and of the commission for the simplification of nonprofit law (2009), and he was the legal consultant for the innovative startup task force organized by the Ministry of Economic Development and for the social innovation task force organized by the Ministry of Education, University and Research (2012). He was a member of the Social Impact Investment Task Force established under the G8 (2014-15), and, since 2016, he is a member of the scientific committee of the association Social Impact Agenda for Italy and of the advisory board of Ashoka Italy. Since 2012, he has been honorary consul of the Republic of Uganda in Milan.
